Federal Life Group, Inc.’s (the “Company”) initial filing with the Commission was a registration statement on Form S-1 that was declared effective on November 6, 2018. On December 11, 2018, the Company’s predecessor held a special meeting and adopted a plan of conversion to convert from a mutual insurance holding company to a stock holding company. That same day the Company completed its initial public offering in which it issued 3,530,150 of its common shares. The Company’s initial Form 10-Q was then due to be filed on December 21, 2018. Due to the time and attention devoted to the events described above, the Company was unable to timely present its draft Form 10-Q to outside auditors for review and approval by the Form 10-Q filing deadline. Therefore, the Company has requested a five day extension in order to give its auditor additional time to review the draft Form 10-Q and provide comments on the disclosure prior to public filing.
